1. Report graffiti to police immediately at 933-4444
 2. Contact BID #37 office at 444-4706 x92 or send an email to:

- Give date and time of your observation
 - Give specific address of property with graffiti
 - Leave phone or email address in case there are further questions

Take Action Against Graffiti

Report Graffiti Immediately!

Graffiti vandalism is a crime.

- Graffiti in progress is a “911” call to the police
- All other graffiti reports should be made to the MPD non-emergency number 414-933-4444

Getting a Grip on Graffiti

Minimize the potential for graffiti to occur on property in your community. Large blank walls or fences attract graffiti. Try the following ideas:

- Plant fast growing vines/shrubs
- Install sensor lighting/cameras
- Use darker paint colors when painting walls or fencing
- Minimize long expanses of empty walls and fencing
- Where possible, use tinted anti-graffiti coating

Free Graffiti Removal Service

BID #37 graffiti removal program is a free* service offered to property owners within the BID boundaries.

To receive graffiti removal services contact Maurice Williams @ 444-4706 x92 or email and leave the following information:

1. First & Last name
2. The organization you represent
3. Specific address of graffiti vandalism
4. Your estimate of how long the graffiti has been present on property
5. A phone number where you may be contacted for further information
6. You may also email graffiti sightings to the following:

A contractor will be assigned by the BID office to remove the graffiti. A permission waiver must be signed by the property owner before any abatement of the graffiti will begin.

What is BID #37 Doing To Fight Graffiti?

BID #37 is committed to stopping graffiti vandalism and has adopted the following Graffiti Action Steps that outlines strategies to curtail graffiti:

- Establishment of a graffiti log
- Photographing and reporting graffiti to the Milwaukee Police to establish property damage profile for graffiti offenders
- Goal of removing graffiti on BID #37 buildings within a week with local Milwaukee contractors
- Working with local businesses, neighborhood groups, and police to protect public/private space and find offenders
- Planning safe and secure public spaces with good lighting and surveillance
